Her research focuses on epistemic justice in development studies and transborder forms of resistance to multiple intermeshed oppressions along lines of gender, race/ethnicity, class, age/generation, sexualities, and body capacities. Darryl S.L. Jarvis is Professor in the College of Public Policy at Hamad Bin Khalifa University in Doha, Qatar. His research interests focus on comparative political economy and comparative public policy, including the politics of regulation, marketisation and development in Asia. His recent publications include *Convergence and Diversity in the Governance of Higher Education: Comparative Perspectives*, Cambridge University Press (with Giliberto Capano); and *Asia After the Developmental State: Disembedding Autonomy*, Cambridge University Press (with Toby Carroll).

Heather Marquette is Professor of Development Politics and Senior Research Fellow (Governance and Conflict) at the UK's Foreign, Commonwealth and Development Office. She is also the director of the Serious Organised Crime and Anti-Corruption Evidence (SOC ACE) research programme. Her research has been funded by the British Academy/Global Challenges Research Fund, DFID, DFAT and the EU, and focuses on corruption and anti-corruption interventions, development politics, aid and foreign policy and transnational organised crime. She is a member of the Global Initiative Against Transnational Organised Crime's Expert Network and Transparency International's Defence and Security advisory group.

Daphina Misiedjan is an Assistant Professor in Human rights and the Environment at the International Institute of Social Studies in The Hague (part of Erasmus University Rotterdam). Nadia Molenaers is Professor of International Cooperation and Development at the Institute of Development Policy of the University of Antwerp, Belgium. Her research focuses on two main themes: she studies whether and how international developments and paradigm shifts influence donor policies and practices and she analyses how donors try to push and pull recipient countries to adapt to or adopt certain policies and governance reforms.

Bronwen Morgan is Professor of Law in the Faculty of Law and Justice, UNSW Sydney, Australia. She previously taught at the Universities of Bristol and Oxford. Her books include *The Rise of the Regulatory State of the South: Infrastructure and Development in Emerging Economies* (with Navroz Dubash, Cambridge, 2013), *An Introduction to Law and Regulation* (with Karen Yeung, Cambridge, 2007) and *Water on Tap: Rights and Regulation in the Transnational Governance of Urban Water Services* (Cambridge, 2011). Her current research explores pathways towards regenerative economies, with a particular focus on energy, food, water and new kinds of lawyers.

Jewellord (Jojo) Nem Singh is Senior Lecturer of International Development at the International Institute of Social Studies, Erasmus University Rotterdam, The Netherlands. He is currently leading

the research programme *Green Industrial Policy in the Age of Rare Metals*, funded through a European Research Council (ERC) Starting Grant. He has published in the fields of international political economy, development and resource governance and is the author of *Business of the State: Why State Ownership Matters for Resource Governance*. He has edited special issues on designing and negotiating industrial policy (*Third World Quarterly*, forthcoming), resource governance and norm domestication in the developing world (*Environmental Policy and Governance*, 2020) and developmental states beyond East Asia (*Third World Quarterly*, 2018).

Caryn Peiffer is Senior Lecturer in International Governance and Public Policy at the School for Policy Studies at the University of Bristol. Nandini Ramanujam is a Full Professor (Professional) at the Faculty of Law, McGill University. She is the Co-Director and Director of Programs of the Centre for Human Rights and Legal Pluralism. Her research and teaching interests include Law and Development, Institutions and Governance, Economic Justice, Food Security and Food Safety, the role of civil society and the Fourth Estate (Media) in promotion of the rule of law, as well as the exploration of interconnections between field based human rights work and theoretical discourses.

Etienne Roy Grégoire is an Assistant Professor in Political Science at the Université du Québec à Chicoutimi (UQAC) and a member of the Centre for Indigenous Conservation and Development Alternatives (CICADA).
