as and, or, on, in, as well as grammatical articles) were removed. The word clouds were then created using the MonkeyLearn WordCloud Generator (<https://monkeylearn.com/word-cloud/>).

The treaties are the one included in the data on Slovakia in the International Treaty Ratification Dataset.
